ENVIRONMENTAL AND SOCIAL COMMITMENT PLAN

- 1. Government of West Bengal is implementing the Dam Rehabilitation and Improvement Project (the Project), with the involvement of Irrigation & Waterways Department, Government of West Bengal, The World Bank (*herein after the Bank*) has agreed to provide financing for the Project.
- 2. Irrigation & Waterways Department, Govt. of West Bengal will implement material measures and actions so that the Project is implemented in accordance with the Environmental and Social Standards (ESSs). This Environmental and Social Commitment Plan (ESCP) sets out material measures and actions, any specific documents or plans, as well as the timing for each of these.
- 3. Government of West Bengal will also comply with the provisions of any other E & S documents required under the ESF and referred to in this ESCP, such as the Environmental and Social Impact Assessments (ESIAs), Environmental and Social Management Plans (ESMPs), Stakeholder Engagement Framework (SEF), Resettlement Policy Framework, Tribal Development Framework, GBV Risk Mitigation Framework, Labor Management Procedure and the timelines specified in those E&S documents.
- 4. Government of West Bengal is responsible for compliance with all requirements of the ESCP.
- 5. Implementation of the material measures and actions set out in this ESCP will be monitored and reported to the Bank by Government of West Bengal as required by the ESCP and the conditions of the legal agreement, and the Bank will monitor and assess progress and completion of the material measures and actions throughout implementation of the Project.
- 6. As agreed by the Bank and Government of West Bengal this ESCP may be revised from time to time during Project implementation, to reflect adaptive management of Project changes and unforeseen circumstances or in response to assessment of Project performance conducted under the ESCP itself. In such circumstances, Government of West Bengal will agree to the changes with the Bank and will update the ESCP to reflect such changes. Agreement on changes to the ESCP will be documented through the exchange of letters signed between the Bank and the Government of West Bengal. The Government of West Bengal will promptly disclose the updated ESCP.
- 7. Where Project changes, unforeseen circumstances, or Project performance result in changes to the risks and impacts during Project implementation, the Government of West Bengal shall provide additional funds, if needed, to implement actions and measures to address such risks and impacts, which may include, *such as environmental, health, and safety impacts, labor influx, gender-based violence*.
