- Sub: Revised Administrative Approval for the work 'Preparation of Detailed Project Report (DPR) to alleviate the flood water-logging and erosion problems in the districts of Howrah and Hooghly in Lower Damodar Region' at a revised estimated cost of ₹ 238.48 lakh under Core State Plan Budget of this Department Subordinate to Demand No. 32 contained in B.P No.20.

The undersigned is directed to say that Administrative Approval for the work 'Preparation of Detailed Project Report (DPR) to alleviate the flood water-logging and erosion problems in the districts of Howrah and Hooghly in Lower Damodar Region' was accorded at an estimated cost of ₹ 216.39 lakh vide this Department No. 153-IB dated 24.12.2012 with the concurrence of Finance Department vide Group-F, U.O No. 653 dated 21.12.2012.

Based on a subsequent proposal of Chief Engineer (Design & Research & Central), vide memo no. 1462-CI/6E-56/12 (D) dated 26.12.2014, the undersigned has been directed to convey accordance of Revised Administrative Approval at a cost of ₹ 238.48 lakh (Rupees two hundred thirty eight point four eight lakh) only for execution of the additional work amounting to about 10.2% of the original estimate through the same agency who were entrusted with the original work on same terms & conditions as of the original tender contract. The expenditure will stand debit-able to the head of account '2711-80-004-SP-003-27-V' out of Core State Plan Budget subordinate to Demand No. 32 as contained in BP No. 20 in the following revised phasing expenditure:

Expenditure already incurred till 2014-15 = ₹ 145.03 lakh Proposed phasing of expenditure for 2015-16 = ₹ 93.45 lakh Total = ₹ 238.48 lakh
