Sub: Administrative Approval for 36 (thirty six) new projects bearing ID No. IW/CSP-370/2018-19 to IW/CSP-405/2018-19 under Capital Outlay of 'State Development Schemes' voted Budget for 2018-19 of this Department subordinate to Demand No. 32 contained in B.P No. 20.

The undersigned is directed to say that the Governor has been pleased to accord Administrative Approval for 36 (thirty six) projects bearing ID No. IW/CSP-370/2018-19 to

IW/CSP-405/2018-19 at an aggregate estimated cost of Rs. 7442.19 lakh (Rupees Seven Four Four Two point One Nine lakh) only as detailed in the Annexure to this Order under Capital Outlay of 'State Development Schemes' voted Budget for 2018-19 of this Department subordinate to Demand No. 32 contained in B.P No. 20 on following terms & conditions:

- a) That all Tender formalities as per Provisions of Rule 47 of WBFR as amended vide FD Notification No. 5400-F(Y) dated 25.06.2012 and all other relevant orders in this respect is to be followed for selection of the contractors/suppliers.
- b) That none of the projects overlaps with a central sector or state sector scheme undertaken by this Department or other Departments of the State Government.
- c) That the Chief Engineer shall ensure that the Executive Engineer has the authority to take up the work on Govt land in question, like obtain written 'NoC' from the concerned Municipal Panchayat Samity & other Local Bodies etc. in terms of FD Notification No. 10184-F(A-II) dated 13.12.2012.
- d) The Departmental Screening Committee (DSC) in the meetings held on 08.06.2018 has already communicated to all concerned regarding initiation of Tender formalities immediately upon clearance of these projects by the DSC.
- e) That special precaution should be undertaken in respect of works to be executed on the ex-zamindary embankment land with prior intimation to the P & RD Department.

This order issues with the concurrence of the Financial Advisor, Irrigation & Waterways Department vide his **U.O. Nos. 129 to 164 Dated 20.09.2018** as mentioned against each of the said 36 schemes under Column 8 & 9 of the <u>Annexure</u> to this Order.
