Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) aims at providing rural employment and as well as creating durable assets capable of improving the livelihood base of rural poor. Govt. of West Bengal has put up a major thrust for MGNREGA State Convergence Action Plan since 2015-16. This department has been entrusted to conserve and extend irrigation network to the rural farming community through State Convergence Action Plan of MGNREGA. This initiative was named as 'SECHBIKASH' (means irrigation enhancement).
