
Sir/Madam,

As already intimated to you vide the Memo under reference, the West Bengal Transgender Persons (Protection of Rights) Rules, 2022 has come into force from the date of its publication in the Official Gazette of the Government of West Bengal on the 30th November, 2022.

As per the Rule 12 of the West Bengal Transgender Persons (Protection of Rights) Rules, 2022 read with Section 11 of Transgender Persons (Protection of Rights) Act, 2019, every establishment will have to designate a Complaint Officer within six months from the date of coming into force of these rules by notification.

In this regard, you are requested to designate a Complaint Officer in every establishment under your control. The details of such Complaint Officer should be notified on the official website and / or at conspicuous places of the premises of such establishment.




