MIS As the Agency named "Corporate Wave Builders", Ashoke Nagar, Post & Dist. Jalpaiguri, being the L1 bidder in connection with the work, "Protection work (for a total length of 6220m) along right bank of river Khulnal at village Karaibari and Changmari (Purbo Dalaigang) (length-1600m), along both bank of river Karala within Patkata G.P. (length-800 m) and right bank at Jolapara (length-550 m), along right bank of river Gilandi at Paschim Pundibari (length-900m) and at Baishchalla (length-570 m), along left bank of river Angravhasa at Nepalibasti (length-900m) and Ajay Ghosh Colony (length-900m) in Block & P.Ss : Jalpaiguri Sadar, Kranti, Dhupguri, Dist. Jalpaiguri."in relation to e-Tender No.\_WBIW/SE/NEIC-II/NIT-5(e)/22-23 floated on 08.09.2022, e-Tender ID no. 2022\_IWD\_402039\_1, miserably failed to comply to submit the Additional Performance Guarantee within the prescribed time without justifiable cause as per clause 5(ii)b of the e-NIT, thereby committing First Degree Offence under Clause 11(D)(vi) & (vii) of e-NIT and as for committing such offence, the penal measure of forfeiture of Earnest Money and debarment for 01 (One) year as per clause 11(G)(b) of e-NIT as initiated by the concerned Executive Engineer, Jalpaiguri Irrigation Division, duly recommended by the Departmental Tender Committee (DTC) in the meeting held on 19.01.2023 in terms of Clause 6.1(e) of the Annexure to Memorandum No.03-W/2017-18, dated 18.05.2017 of Irrigation & waterways Department, the Agency Corporate Wave Builders", Ashoke Nagar, Post & Dist. Jalpaiguri is hereby debarred to participate in all tenders of Irrigation & Waterways Department for a period of 1 (One) year with effect from 20.01.2023 and the Earnest Money of the bidder stands forfeited.

The Superintending Engineer, North-East Irrigation Circle-II, I & W Directorate, is hereby instructed to take necessary action to forfeit the Earnest Money deposited by the bidder with immediate effect.

This order shall be brought to the notice of all concerned for strict compliance.
