NOTIFICATION

It transpires from the records produced that the Firm in the name of “Sujoy Krishna Jana” and another Firm in the name of “M/s. Sujoy Krishna Jana & Co.” both had participated in a works tender under **Sl. No.2 of e-NIT No.WBIW/SE/EC/NIT-13(e)/2022-23 of Eastern Circle, I&W Dte.** for the same work. Both of them submitted along with their e-bids, Form-2, relating to declaration against common interests. It has been revealed that the Firm named “Sujoy Krishna Jana” is a proprietorship Firm and the other bidding Firm i.e. “M/s. Sujoy Krishna Jana & Co.” is a partnership Firm, where Sujoy Krishna Jana is also one of the partners. It is clearly established from Firm address, assessee no. partnership deed etc that both the persons are one and the same.

Thus, documents submitted in their e-bids by the two bidders clearly establishes that there has been concealment of information in the bids as declared in Form-2 of e-tender which tantamount to influencing the outcome of eligibility of screening during technical bid evaluation stage.

Now, based on the recommendation of the HTEC dt.19.04.2023 and the Govt. Appointed Departmental Tender Committee dt.04.05.2023 and opinion of the I&W Dept. vide Memo No.225-IB dt.02.08.2023, both the bidders are hereby debarred from participating in any future work under Irrigation & Waterways Dept. or elsewhere, as applicable, with immediate effect in a manner tabulated below:
