NOTIFICATION

It transpires from the record produced that the firm in the name of "M/S Debi Construction" in an e-tender bearing e-NIT No. *WBIW/EE/JOY/NIT-08(e)/2023-24 (SI-03)* having *e-Tender ID – 2023_IWD_534203_3* of Executive Engineer – II, Joynagar Irrigation Division, during the technical evaluation stage, the Tender Evaluation Committee (TEC) found that one of the participating bidders i.e. "M/S. Debi Construction" had submitted at dubious PQ credential. The Executive Engineer-II, Joynagar Irrigation Division immediately thereafter obtained a written confirmation for verification in this regard from the Executive Engineer, Kakdwip Irrigation Division vide his Memo No.1151 dt.03.07.2023 (PQ credential issuance authority) which has confirmed that the PQ credential uploaded by the bidder is forged and false.

The tender accepting authority (Executive Engineer-II, Joynagar Irrigation Division) vide his Memo No.931-EII dt. 06/07/2023 had asked the bidder "M/S. Debi Construction" to physically present himself before him and produce the work credential in original within next 3 working days. However, the said "M/S. Debi Construction" failed to attend or communicate on the matter.

Earlier, in a similar case, "**M/s. Debi Construction**" while participating in another e-tender during 2022-23 under Executive Engineer-I, Joynagar Irrigation Division bearing e-NIT No. WBIW/EE/JOY/NIT-21(e)/2022-23 (SI.-6) had also submitted falsified PQ credential.

Now based on the recommendation of the Government appointed Departmental Tender Committee (DTC) in its meeting dt. 21/07/2023 and subsequent opinion of the Government in the Irrigation & Waterways Department communicated vide Memo No. 317-IB-IW-14011(33)/2/2021-SECTION(IW) (Pt-2) dated 27/09/2023, as the bidder "**M/S. Debi Construction**" has committed the offence on more than one occasion, the penalty would be for a 2nd degree of offence i.e. the debarment period shall be two times that of 1st degree of offence for 12 months vide Clause 9E c of the e-NIT. The bidder is hereby debarred from participating in any future work under Irrigation & Waterways Department or elsewhere, as applicable for 12 months from this date. In addition, the earnest money deposit is also forfeited.
