### OFFICE ORDER

Dated, Purba Bardhaman, the 1<sup>st</sup> Nov, 2023.

As the Agency named Kajal Dey, Mukherjee Lane, Kamarpara, Chinsurah, Hooghly being L1 Bidder in connection with the work 'Bank Protection to the right bank of river Hooghly for a length of 300m. at Tribeni, P.S.Mogra, Dist. Hooghly' in relation to e-Tender No. WBIW/SE/DIC/NIT-14(c)/2022-23 (Serial-1), e-Tender ID No. 2023\_IWD\_500175\_1, miserably failed to comply to submit the Additional Performance Guarantee within the prescribed time without justifiable cause as per Clause 5(ii)(b) of e-NIT thereby committing First degree Offence under Clause 11(D)(vi) of e-NIT and 11(E) (a) as for committing such offence, the penal measure of forfeiture of Earnest Money and debarment for 01 (one) year as per Clause 11(G) (b) of e-NIT as initiated by the concerned Executive Engineer-II, Lower Damodar Irrigation Division, duly recommended by Technical Evaluation Committee (TEC) and finally approved by the Departmental Technical Committee (DTC) in the meeting held on 28.08.2023 as per 10 (A) of e-NIT and in exercise of the power conferred upon the undersigned in terms of Clause 3.6, 4.1 and 5.0 (Row-2) of the Annexure to Memorandum No. 03-W/2017-18 dated 18.05.2017 of Irrigation & Waterways Department, the Agency 'Kajal Dey, Mukherjee Lane, Kamarpara, Chinsurah, Hooghly' is hereby debarred to participate in all tenders of Irrigation & Waterways Department for a period of 01 (One) year with effect from 01.11.2023 and the Earnest Money of the Bidder stands forfeited.

The Superintending Engineer, Damodar Irrigation Circle, Irrigation & Waterways Directorate, is hereby instructed to take necessary action to forfeit the Earnest Money deposited by the Bidder with immediate effect.

This order shall be brought to the notice of all concerned for strict compliance.




