NOW, THEREFORE, a **Departmental Vigilance Committee** is hereby constituted comprising of the following officials of Irrigation & Waterways Department to inquire into the issues referred to them, from time to time, by the Irrigation & Waterways Department:

Committee.

It is clarified that if a complaint/allegation is received against the Chief Engineer (D&R), Irrigation &Waterways Directorate, such post in the Committee shall be manned by any of the Chief Engineers as may be decided by the Head of the Irrigation &Waterways Department, and to be communicated to the Committee, accordingly.

The procedure and functioning of such Committee will be decided by the Committee itself to be taken in its meeting.

The Committee shall submit its report in writing to the Head of the Irrigation & Waterways Department within 15 (fifteen) days from the date of completion of inquiry thereof.
