The senior most Superintending Engineer will act as the Chairman of this Committee and the Executive Engineer, Investigation & Planning Division (South) will act as the Member Convener of this Committee.

B) Terms of Reference [ToR] of DLTEC

- i)The Committee will primarily check all the uploaded documents of preliminary Technical Bid Evaluation (TBO) summay sheet and final Technical Evaluation (TBE) summary sheet to verify if required documents, as per e-NIT, have been uploaded or if there is any short-comings in this regard.
- ii)Detailed examinations of such uploaded documents will be carried out by the Committee ,if (a) any significant shortcoming is noticed by the Committee while conducting primary checking in the manner stated at sl-i above or (b) any complaint against any such technical evaluation of any e-tender is received by the committee through the Department.

iii) Gross violation of the e-tender norms, found, if any, by the Committee, should be brought to the notice of the Department through the email id secy@wbiwd.gov.in within one working day.

iv) The Committee, while carrying out detailed examination as stated at SI-ii above, may ask for submission of any additional documents/information from the respective TIA, if required.
