It may be noted that 3(three) posts of A.C.R.O. under the Regional Quota(as per new Recruitment Rule vide Notification No:95-IRC dated 02.09.2019) have been lying vacant in different Revenue Divisions under I & W Dte.

With a view to filling up the vacant posts, all the Head clerks who have rendered at least 5(five) years of combined service in the post of Head Clerk & U.D.C and all Upper Division clerks who have rendered at least 5(five) years of service in the post of U.D.C posted in different Regional Offices under this Directorate are hereby instructed to inform their willingness/unwillingness to accept the promotion to the said post of A.C.R.O. within 20(Twenty) days of issuance of this Notification, in the format enclosed herewith. All eligible incumbent(s) are instructed to send their options directly to the office of the undersigned subject to intimation to their respective higher authority.

It is noteworthy to mention in this context that no option received after the stipulated period will be entertained and the respective incumbent(s) will be treated as unwilling to accept the aforesaid promotion to the post of ACRO.
