Sub: Approval for opening of 24 nos. of new heads of account for booking of capital expenditure of Irrigation & Waterways Department, Government of West Bengal under State Plan relating to Centrally Assisted State Sector Projects under AIBP and OTACA, Subordinate to Demand No. 32 as contained in B.P No. 20.

Irrigation & Waterways Department is executing Major Irrigation Project (Teesta Barrage Project a National Project) and Medium Irrigation Projects (Tatko Irrigation Project and Patloi Irrigation Project both special category projects) under the centrally assisted programme of Accelerated Irrigation Benefit Programme (AIBP) under State Plan in the funding pattern of 90% Central grant & 10% as matching State Share. This Department is also executing Irrigation and Flood Control cum drainage sector projects under the Centrally assisted programme "One Time Additional Central Assistance" (OTACA) under State Plan in the funding pattern of 30% Central grant & 70% as matching State Share. As of now, there was no separate Heads of Account for charging Central share and State share for the projects under AIBP and OTACA in B.P No.20. Both Central and State Share expenditure used to be booked against the same Head of Account which is **to be kept dormant w.e.f 07.11.14** as detailed in the *Annexure*.

As per circular of Govt. of India and guidelines of AG, West Bengal, it has now become mandatory to book expenditure of Central share and State share separately under designated Heads of Account for Centrally Assisted State Plan programmes.

In the above context, the undersigned is directed to convey the approval of the Principal Accountant General (A&E), West Bengal for opening of 24 nos. of new heads of account for booking of capital expenditure to be incurred by Irrigation & Waterways Department, Govt. of West Bengal under State Plan budget relating to Centrally Assisted State Sector Projects approved under AIBP and OTACA, Subordinate to Demand No. 32 as contained in B.P No. 20 as detailed in the next page.
