The concerned officers are, hereby requested to handover a copy of this order to each of such employees under their control, immediately. They are also requested to take further actions as enumerated below :-

In case of unwillingness to accept the promotion as stated hereinbefore, the concerned employee will have to abide by the order dated 29.03.2011, communicated with this office memo. no, 1137 (45)-CIE dated 18.04.2011 and the matter of such **refusal of promotion**, shall have to be recorded in the **Service Book** of the concerned employee forgoing such promotion, and after recording the same , the Service Book (in original) must be sent to this office for necessary verification in this regard.

c) The Administrative Officer, Establishment Cell-I, Office of the Chief Engineers, Irrigation & Waterways Directorate.
