Agenda: Short listing of additional projects in conformity with approved allocation under Core State Plan budget during the current financial year of 2017-18.

Secretary took the chair. Financial Advisor, Chief Engineer (South West) and other officers remained present.

The following were discussed:

- 1. Technically sanctioned DPR of 21 new schemes at an aggregate estimated cost of Rs 31.52 Crore were initially placed before the DSC for consideration.
- 2. Major discrepancies were identified in the schemes for construction of CC Road including special repair of sluice over Mirzapur khal (Rs. 36.29 lakh), Re-excavation of Chapda Gazai khal in Kolaghat (Rs. 44.41 lakh), Protection of left bank of Dwarakeswar at Ghatal (Rs. 135.00 lakh), Construction of Inspection path on right bank of River Deuli at Sabang (Rs. 58.13 lakh) and Extension of Check Dam in Raghunathpur-II in Purulia (Rs. 155.14 lakh).
- 3. Above five schemes were dropped and Chief Engineer (South West) was requested to resubmit the proposals after careful scrutiny and fresh assessment.
- 4. All the remaining 16 projects were found to be more or less in order. Only the names of most of the schemes had to be partly modified by the DSC to make them commensurate with the fitment requirement of Plan for funding. Two schemes relating to development of infrastructure & buildings have also been included. The names of these schemes thus decided in the meeting would only be considered during accordance of formal Administrative approvals and tenders are to be invited accordingly.
- Chief Engineer (South West) certified that there is no duplication of proposals with other sources of funding. All the schemes have been selected on the basis of prioritised ground requirements within approved allocation.

- 6. Finally 16 no. of schemes at an aggregate cost of Rs. 27.17 crore were cleared by the DSC for inclusion under Core State Plan Budget of this Department during the current financial year of 2017-18.
- 7. Tenders may be invited immediately.

The meeting ended with vote of thanks.
