The concerned Superintending Engineers and Executive Engineers also remained present.

Agenda: Clearance of projects in conformity with approved allocations under State Development scheme budget during the current financial year of 2018-19 for inclusion under RIDF-XXIV and Core Sector.

Secretary took the chair. Financial Advisor, Chief Engineer (West), Chief Engineer (South) and other officers remained present.

The following were discussed:

- 1. Technically sanctioned DPR of 28 no. new schemes posed under RIDF-XXIV at an aggregate estimated cost of Rs 148.44 Crore were initially placed before the DSC for approval. Three other prioritized schemes at an aggregate estimated cost of Rs 53.58 Crore were posed under Core Sector.
- 2. The DSC advised the Chief Engineers and other Engineers to frame the schemes in conformity with the Departmental guide lines of lining works and those for bank protection works. However, relaxation to compliance of lining manual was provided for RIDF Schemes considering that the guideline was published very recently.
- 3. I no. scheme of Siliguri Irrigation Division was rejected due to faulty Rate Analysis. The scheme was directed to be re-submitted early for inclusion under RIDF-XXIV.
- 4. Nomenclature of a few schemes was modified to make them commensurate with the capital works and some minor corrections were incorporated.
- 5. All the Chief Engineers certified that there is no duplication of proposal with any other sources of funding, and all the schemes have been selected by them on the basis of prioritized ground level requirements.
- 6. Finally 28 (twenty eight) no. of new schemes at an aggregate cost of Rs. 148.44 crore were cleared for inclusion under RIDF-XXIV. The allocation for RIDF-XXIV including spillover of RIDF-XXIII was communicated vide this Department No. 54-IB dated 20.04.2018 amounting to Rs. 203.18 crore against which spillover amount is Rs. 54.74 crore and new schemes for Rs. 148.44 crore. The Nodal Officer, i.e. Chief Engineer (South) was directed to submit all the schemes to the NABARD Kolkata Office within a day or two.
- 7. 3 no. schemes at an aggregate cost of Rs. 53.58 crore were cleared under Core Sector of State Development Schemes Budget of this Department during the current financial year of 2018-19. Tenders for the 3 projects cleared under Core Sector may be invited.
