Sub: Handing over the charges of the jurisdiction of Right Bank Irrigation Division under Damodar Irrigation Circle and Hooghly Irrigation Division under Western Circle - I.

I am directed to state that 04 (Four) Irrigation Divisions were designated as dedicated District Project Implementation Unit (DPIU) in connection with WBMIFMP vide this Department Notification No.12-W/2017-18. Out of the said 04 (four) Divisions, 02 (Two) Divisions i.e. (1) Burdwan Irrigation Division and (2) Howrah Irrigation Division, started to perform as dedicated District Project Implementation Unit (DPIU) with effect from 1<sup>st</sup> January'2018 in terms of this Department's Memo No. 499(4)-IB dated, 13.12.2017.

2. Now, I am further directed to state that the remaining 02 (Two) Divisions i.e. (1) Right Bank Irrigation Division and (2) Hooghly Irrigation Division, are declared as operational DPIUs with effect from 9<sup>th</sup> July 2018, and will perform dedicated functioning for preparation of the project including supervising the ongoing consultancy works on Feasibility Study, Bidding Documents and Environmental and Social Impact Assessment, on full time basis and

will be under overall control of Chief Engineer & Project Director, State Project Management Unit, WBMIFMP, on and from that date.

- 3. The said 2 Divisions will hand over jurisdiction and work load including existing staffs of concerned Sub-Divisions to other designated Divisions, in the manner as detailed in Notification No. 12-W/2017-18 dated 8<sup>th</sup> August 2017. Concerned Executive Engineers will follow procedure for handing over staffs of effected Sub-Divisions in the manner as stated at Annex-14 of above stated Notification including the following actions.
  - i) Executive Engineers of concerned Divisions will make a list of category-wise detailed list of sanctioned posts and staffs in concerned Sub-Division Offices, which are to be transferred to other designated Divisions, and handover the same to the new Divisions.
  - ii) Necessary tagging and un-tagging of staffs in HRMS module of concerned Sub-Divisions will be done after issuance and acceptance of LPC.
- 4. This issues with the approval of Additional Chief Secretary of this Department, and is to be completed forthwith.
