ORDER

The undersigned is directed on behalf of the Governor to say that the Governor is pleased to constitute a Departmental Technical and Tender Committee (DTTC) mainly for technical evaluation of the bids in connection with the work *“Design, Supply, Integration, Installation, Testing conduction trial runs and commissioning of State-of-the-Art SCADA based automatic reservoir automation of Messanjore Dam including refurbishment of hydro-mechanical and electrical drive systems of Mayurakshi Reservoir project located at Messanjore, P.S Dumka in the State of Jharkhand under Irrigation & Waterways Department, Government of West Bengal”*.
