Sir,

This is to bring your kind notice that 6 (Six) Junior Engineers of this Department as mentioned in column 2 in the table below had been transferred from their parent places of postings as mentioned in column 4 and posted in the Office as mentioned in column 5 vide this Directorate's Order No. 130(140)-CIE-2T-02/2015 dated 22/01/2015, 2120(140)-CIE/2T-19/2015 dated 02/05/2017 and this Department's Notification No.22-IE dated 19/03/2018 and 20-IE dated 19/03/2018 respectively as mentioned in column 3 against each incumbents but it has come to the notice of the Department that the officers have not been released yet from their previous places of posting by the concerned Executive Engineers and have not joined in their new assignments in compliance with the said orders/Notifications.
