<u>ORDER</u>

In pursuance of Notification No. 192-IT/06/2020/P&AR-e-Gov dated 16.10.2020 of Personnel & Administrative Reforms Department, Govt. of West Bengal, the Governor is hereby pleased to say that the service of 6(Six) nos. of IT Personnel engaged through other agencies (List of the staffs in this strength annexed herewith), contractually under this Department are hereby come under the direct control of this Administrative Department as 'contractual workers' and their service will continue until they attain 60 years of age or till their termination in the grounds as prescribed in Finance Department's Memorandum No. 9008-F(P) dated 16.09.2011. They are also eligible to enjoy the following benefits in terms of Notification No. 192-IT/06/2020/P&AR-e-Gov dated 16.10.2020 of Personnel & Administrative Reforms Department, Govt. of West Bengal:

- a. 30 days leave in a calendar year.
- b. 10 days leave on medical ground.
- c. Maternity leave (in case of female employee) 180 days and 42 days in case of abortion/miscarriage.
- d. Terminal benefit on attaining the age of 60 years @ Rs. 3.00 Lakhs.
- e. They will come under 'Swasthya Sathi Scheme' if he/she is not covered under WBHS being a spouse of an employee of State Government.

Aforesaid benefits will be taken effect from 01.11.2020 in terms of Notification No. 192-IT/06/2020/P&AR-e-Gov dated 16.10.2020 of Personnel & Administrative Reforms Department, Govt. of West Bengal. P & AR Department will be the Nodal Department in respect of such IT Personnal.

Henceforth, the Professional Fee/ Remuneration of the 6 (Six) nos. of IT Personnel (List of 6 nos. of IT Personal annexed herewith) will be governed by Finance Department's Memorandum No. 5859-F(Y) dated 22.07.2013 along with its extended Memorandum No. 1032-F(P2) dated 08.02.2019 and it will be come in force on and from date of issue of the order at the same Professional Fee/ Remuneration where they actually stand on the previous day of issuing the order and afterwards yearly enhancement of remuneration will be strictly governed by aforesaid orders, when they actually complete their per year tenure individually.

Concerned Executive Engineer/Deputy Director/Revenue Officer will act as DDO, wherein such IT Personnel are already posted.

In all cases Remuneration of such employees will be charged under detailed head "02-wages"
