One scheme (under sl 1) for re-excavation of old Monikhali khal from DD-1 khal to outfall at Hooghly river including bank protection works within Ward No. 8,17,18,19 Maheshtala Municipality, Dist - South 24 Pgs under Executive Engineer, Subarbun Drainage Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 119<sup>th</sup> Meeting held on 21.11.2024.This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

2. One scheme ( under sl 2) for construction of fencing along both banks and bridges of Western Channel from Keorapukur old pump house to water reservoir of K.M.C. near Shoni Temple within Ward nos. 114 ,142 of K.M.C., P.S.-Regent Park, Dist.-Kolkata under Executive Engineer-II, Canals Division initially technically recommended by the Directorate Level Technical Committee of I.&W.Dte. in their 117<sup>th</sup> Meeting held on 30.09.2024 followed by Departmental Technical Committee of Chief Engineers in their 335<sup>th</sup> Meeting held on 25.11.2024.This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

This scheme has been placed in the present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
