- One scheme (under sl 1) for construction of ring bundh along right bank of river Borokalagachi in between Atapur ICDS school and Atapur Taltala Ghat within GP-Monipur, Block –Sandeshkhali-II, PS- Sandeshkhali, Dist Noth 24 Pgs under Executive Engineer, Basirhat Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 100th Meeting held on 01.03.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 2. One scheme (under sl 2) for construction of ring bundh along left bank of river Raimongal near Sardarpara at Madhabkati within Block and PS-Hingalganj, Dist Noth 24 Pgs under Executive Engineer, Basirhat Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 100th Meeting held on 01.03.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 3. One scheme (under sl 3) for protection work along left embankment of river Hooghly near Raichak Bus Stand within GP Noorpur , Block Diamond Harbour II, PS-Diamond Harbour , Dist.- South 24 Pgsunder Executive Engineer-II , Canals Division initially technically recommended by the Directorate Level Technical Committee in their 130th Meeting held on 24.01.2025. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

One scheme (under sl 4) for protection work along left embankment of river Hooghly from Pulermar sluice to Hatkhola sluice at Noorpur within Block-Diamond Harbour-II, P.S –Ramnagar, Dist-South 24 Pgs. under Executive Engineer-II , Canals Division initially technically recommended by the Directorate Level Technical Committee in their 129th Meeting held on 17.01.2025 followed by Departmental Technical Committee of Chief Engineers in their 340 Meeting held on 29.01.2025. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

- 5. One scheme (under sl 5) for anti-erosion work to fill up scour hole along left bank of river Hooghly adjacent to Roypur Jetty within Block- Budge Budge II, P.S Nodakhali, Dist.- South 24 Pgs. under Executive Engineer-II, Canals Division initially technically recommended by the Directorate Level Technical Committee in their 130th Meeting held on 24.01.2025 followed by Departmental Technical Committee of Chief Engineers in their 341 Meeting held on 31.01.2025. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 6. One scheme (under sl 6) for protection work along left bank of river Ganga from Manikchak Ferry Ghat towards upstream at Naryanpur within Block and P.S.-Manikchak, Dist.- Malda under Executive Engineer , Malda Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 123th Meeting held on 20.12.2024 followed by Departmental Technical Committee of Chief Engineers in their 339 Meeting held on 08.01.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 7. One scheme (under sl 7) for improvement of inspection road from Shyamsundarpur to Basulia and embankment along right Ex Zamindari embankment of Banskona Khal at Mouzas Shyamsundarpur, Basulia within GP-11 no. Mohar, Block and PS-Sabang, Dist. Paschim Medinipur (Ref : SSM) under Executive Engineer, K.K.B.Project Division initially technically recommended by the Directorate Level Technical Committee in their 124th Meeting held on 31.12.2024 This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 8. One scheme (under sl 8) for protection work along left bank of river Mahananda at Mahananda para within Ward No. 10 under Siliguri Municipal Corporation, P.S.- Siliguri Dist- Darjeeling under Executive Engineer, Siliguri Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 129th Meeting held on 17.01.2024 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

- 9. One scheme (under sl 9) for restoration of spur no. 2,3,4,5 ,6 of Dakshin Changmari Embankment and New Changmari Embankment along left bank of river Teesta within Block Kranti, PS Mal, Dist: Jalpaiguri under Executive Engineer, Jalpaiguri Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 129th Meeting held on 17.01.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 10. One scheme (under sl 10) for protection work along right bank of river Sisamara within GP- Salkumar -I, Block Alipurduar-I, PS Alipurduar Dist- Alipurduar. (Ref : SSM) under Executive Engineer, Alipurduar Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 129th Meeting held on 17.01.2024. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 11. One scheme (under sl 11) for protection work along right embankment of river Reti-Sukriti near Karbala forest area (total length of 200 M) within Block and P.S.-Banarhat, Dist.-Jalpaiguri under Executive Engineer, Jalpaiguri Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 130th Meeting held on 24.01.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 12. One scheme (under sl 12) for installation of hoisting arrangement including replacement of seal path of all flap shutters of 22 vent Sluice at Baisha withinin Block: Ramnagar-II, P.S- Mandarmani Coastal, District: Purba Medinipur.under Executive Engineer, Mechanical & Electrical Division, Midnapore initially technically recommended by the Directorate Level Technical Committee in their 130th Meeting held on 24.01.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 13. One scheme (under sl 13) for installation of hoisting arrangement of all flap shutters of 30 vent Sluice at Kuliyata within Block: Ramnagar-I, P.S- Ramnagar, District: Purba Medinipur. under Executive Engineer, Mechanical & Electrical Division, Midnapore initially technically recommended by the Directorate Level Technical Committee in their

- 14. One scheme for repair of eight no. Steel Foot Bridges and one no. RCC Foot Bridge over New Cut Canal and Kestopur Khal within South Dum Dum Municipality and Bidhannagar Municipal Corporation, District-North 24 Parganas. under Executive Engineer-I, Canals Division initially technically recommended by the Directorate Level Technical Committee in their 127^{7h} Meeting held on 10.01.2025. This scheme has been placed in present DSC meeting and it has been resolved that the scheme may be taken up under SDS maintenance fund considering nature of work.
- 15. One scheme for improvement with widening of carriageway of the existing RCC Bridge at Dum Dum Park over Upper Bagjola khal (Ch. 8380 M) within Ward No. 28 & 29 of South Dum Dum Municipality, P.S. Laketown, Dist. North 24 Pgs under Executive Engineer-I, Canals Division initially technically recommended by the Directorate Level Technical Committee in their 127th Meeting held on 10.01.2025 .This scheme has been placed in present DSC meeting and it has been resolved that the scheme may be taken up under SDS maintenance fund considering nature of work.
- 16. One scheme for toe protection of Rup Right schedule D embankment from house of Arjun Singh, Mouza- Baramritberia to Kichukkhon resturant, Mouza-Ichhapur in Blocks-Mahisadal & Nandakumar, District-Purba Medinipur under East Midnapore Division, initially technically recommended by the Directorate Level Technical Committee in their 129th Meeting held on 17.01.2025 .This scheme has been placed in present DSC meeting and it has been informed that one scheme at same reach accorded administrative approval under RIDF XXX, tender of which has been invited. To avoid overlapping of site, it has been resolved that the said e-NIT is to be cancelled at the earliest and one combined scheme on present ground reality is to be placed, after due recommendation of DLTC, to the Department for funding under CSDS or any other suitable source of fund.

17. Finally, 12 no. schemes as per Annexure have been cleared by the DSC for inclusion under Core State Development Schemes during the current FY 2024-25.
