Agenda: Proposal for recommendation of 15 (fifteen) new schemes (all schemes costing below Rs 5.0 crore) for inclusion under Core State Development Schemes (Voted) budget of Irrigation & Waterways Department during the current FY of **2024-25**  Secretary took the chair. The following were discussed ;

- One scheme (under sl 1) for protection work along left bank of river Hooghly adjacent to Barrackpore Police Commissioner Bunglow ,within Ward No. 21, Barrackpore Municipality, P.S.-Barrackpore, District -North 24 Pgs under Executive Engineer-I, Canals Division initially technically recommended by the Directorate Level Technical Committee in their 112<sup>th</sup> Meeting held on 02.08.2024 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 2. One scheme ( under sl 2 ) for special repair of C.C. block lining and fencing work along both bank of CC1 West Branch Channel within Ward No. 107 of KMC area , P.S.-Kasba , Dist : South 24 Pgs under Executive Engineer ,Metropolitan Drainage Division No–II, initially technically recommended by the Directorate Level Technical Committee in their 132<sup>th</sup> Meeting held on 30.01.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- **3.** One scheme ( under sl 3 ) for sea -shore protection work by Nature Based Solution (NBS) from sand dunes beside Sankaracharya Ashram towards Tapabon upto wooden cottage at PR-5 in front of Kapil Muni Ashram at Gangasagar within Block and PS Sagar Dist : South 24 Pgs under Executive Engineer , Kakdwip Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 136<sup>th</sup> Meeting held on 27.02.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

One scheme ( under sl 5 ) for reconstruction of left ex-zamindari embankment of river Silabati at Hiradharpur within G.P-Monoharpur-l ,Block-Chandrakona-l , PS-Chandrokona Dist- Paschim Medinipur.under Executive Engineer ,Kangsabati Canals Division No- I, initially technically recommended by the Directorate Level Technical Committee in their 131<sup>th</sup> Meeting held on 29.01.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 6. One scheme ( under sl 6 ) for reconstruction of left ex-zamindari embankment of river Silabati at Bhabanipur within GP- Manikkundu , Block-Chandrakona-l Block , Dist-Chandrokona District- Paschim Medinipur..under Executive Engineer ,Kangsabati Canals Division No- I, initially technically recommended by the Directorate Level Technical Committee in their 131<sup>th</sup> Meeting held on 29.01.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 7. One scheme ( under sl 7 ) for improvement of Milanpally bank protection work and Biren Basty embankment along right bank of river Teesta within Block Rajganj ,PS Bhorer Aalo, Dist- Jalpaiguri under Executive Engineer , Jalpaiguri Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 133<sup>th</sup> Meeting held on 06.02.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 8. One scheme ( under sl 8 ) for restoration of Spur no. 149 of Bakali embankment at left bank of river Teesta within GP- Dharampur , Block and PS : Maynaguri , Dist.: Jalpaiguri under Executive Engineer , Jalpaiguri Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 133<sup>th</sup> Meeting held on 06.02.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

One scheme ( under sl 10 ) for protection work along left bank of river Kurunda at Bhojnarayan nichline area, within GP-Hetmuri Singhijhora ,Block and P.S- Phansidewa, Dist.- Darjeeling under Executive Engineer ,Siliguri Irrigation Division, initially technically recommended by the Directorate Level Technical Committee in their 133<sup>th</sup> Meeting held on 06.02.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 11. One scheme ( under sl 11 ) for protection to Spur no. 4,5 ,6 of Mondalghat-Bibiganj embankment within GP-Nandanpur-Boalmari ,Block-Jalpaiguri Sadar, P.S.-Kotwali, Dist Jalpaiguri and Spur no. 4 of Bibiganj-Jharsingheshwar embankment along right bank of river Teesta within GP Per Mekhliganj , Block and P.S.-Haldibari, Dist- Coochbehar under Executive Engineer ,Jalpaiguri Irrigation Division, initially technically recommended by the Directorate Level Technical Committee in their 124<sup>th</sup> Meeting held on 31.12.2024 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 12. One scheme ( under sl 12 ) for replacement of 5 (five) no. draw shutters and 2 ( two) no. flap shutters and allied works of 11 vented Fuleswar sluice within Block Uluberia-I, PS-Ulberia, Dist- Howrah.under Executive Engineer , Metropolitan Electrical Division, initially technically recommended by the Directorate Level Technical Committee in their 133<sup>th</sup> Meeting held on 06.02.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.

- 13. One scheme ( under sl 13 ) replacement of 4 (four) no. draw shutters and 6 ( six ) no. flap shutters and allied works of 20 vented Sejberia sluice within Uluberia Municipality , PS-Ulberia, Dist- Howrah.under Executive Engineer , Metropolitan Electrical Division, initially technically recommended by the Directorate Level Technical Committee in their 133<sup>th</sup> Meeting held on 06.02.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 14. One scheme ( under sl 14 ) for Replacement of 5 (five) no. draw shutters ,5 ( five) no. flap shutters and implementation of Electro-Mechanical hoisting system of Rudranagar sluice within Block and PS-Tehatta-II, Dist.- Nadia under Executive Engineer , Metropolitan Mechanical & Electrical Division initially technically recommended by the Directorate Level Technical Committee in their 133<sup>th</sup> Meeting held on 06.02.2025 .This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 15. One scheme ( under sl 15 ) for replacement of 3 (three) no draw shutters, 4 (four) no flap shutters including hoisting arrangement of Ghomrai sluice over Palaspai river, Block:-Daspur-II, P.S:-Daspur, Dist-Paschim Medinipur., Mechanical & Electrical Division, Midnapore, initially technically recommended by the Directorate Level Technical Committee in their 134<sup>th</sup> Meeting held on 12.02.2025. This scheme has been placed in present DSC meeting and recommended with some modification in name of work and some attachment within scheme booklet.
- 16. Finally, 15 no. schemes as per Annexure have been cleared by the DSC for inclusion under Core State Development Schemes during the current FY 2024-25.
