Agenda: Proposal for recommendation of 04 (Four) new schemes (04 schemes costing above Rs 5.0 crore) for inclusion under Core State Development Schemes(Voted)budget of Irrigation & Waterways Department during the current FY of 2024-25 Secretary took the chair. The following were discussed ;

- One scheme (under sl 1) for construction of Sundarban embankment along left bank of river Chotokalagachi at Dwarir Jungle within Block: Sandeshkhali-II, PS- Sandeshkhali, District- North 24 Pgs under Executive Engineer, Basirhat Irrigation Division, initially technically recommended by the Directorate Level Technical Committee in their 109th Meeting held on 04.07.2024 followed by Departmental Technical Committee of Chief Engineers in their 330 Meeting held on 16.08.2024, has been placed in present DSC meeting. After discussion the scheme has been recommended with some modification in name of work and some attachment within scheme booklet.
- 2. One scheme (under sl 2) for protection work along right bank of river Padma from house of Islam Uddin to BSF camera post at Radhakrishnapur within G.P- Bilborakopra, Block and P.S- Lalgola, Dist- Murshidabad under Executive Engineer, Ganga Anti Erosion Division No.-I initially technically recommended by the Directorate Level Technical Committee in their 129th Meeting held on 17.01.2025 followed by Departmental Technical Committee of Chief Engineers in their 343 Meeting held on 07.02.2025. , has been placed in present DSC meeting. After discussion the scheme has been recommended with some modification in name of work and some attachment within scheme booklet.
- 3. One scheme (under sl 3) for protection work with bamboo porcupine spurs along right bank of River Rasulpur near Rasulpur ferry ghat, Uttar Dihimukundapur and Ghoraghata near Sunia ghat within GP.- Amtalia ,Block- Deshapran, PS.- Contai, Dist.- Purba Medinipur. (Ref : SSM) under Executive Engineer, Contai Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 133th Meeting held on 06.02.2025 followed by Departmental Technical Committee of Chief Engineers in their 344 Meeting held on 17.02.2025. , has been placed in present DSC meeting. After discussion the scheme has been recommended with some modification in name of work and some attachment within scheme booklet.

- 4. One scheme (under sl 4) for construction of R.C.C. Bridge over Kaliaghai River at Langalkanta within G.P.-Bishnupur, Block and P.S-Sabang, Dist.- Paschim Medinipur under Executive Engineer, Contai Irrigation Division initially technically recommended by the Directorate Level Technical Committee in their 132th Meeting held on 30.01.2025 followed by Departmental Technical Committee of Chief Engineers in their 345 Meeting held on 19.02.2025. , has been placed in present DSC meeting . After discussion the scheme has been recommended with some modification in name of work and some attachment within scheme booklet.
- 5. One scheme for de-siltation of Teesta Mahananda Link Canal under Teesta Barrage Project within Block- Rajganj, P.S- Bhorer Alo, Dist. Jalpaigur under Executive Engineer –Teesta Left Bank Division, initially technically recommended by the Directorate Level Technical Committee in their 123th Meeting held on 20.12.2024 followed by Departmental Technical Committee of Chief Engineers in their 340 Meeting held on 29.01.2025, has been placed in present DSC meeting. After discussion it has been resolved that the scope of work, particularly the section of dredging, considered in this scheme needs to be reviewed by the Central Design Office. It was also decided that the dredging of canal can be taken up adopting No Cost Basis from Govt. Exchequer model. So proposal is to be submitted by Chief Engineer (TBP) to the Department along with soil test report and all other hydraulic data like length, width, depth of proposed cutting etc.

6. One scheme under Chief Engineer (SW) for toe protection of Rup Right schedule D embankment for a length 3100 m from house of Arjun Singh, Mouza- Baramritberia to Kichukkhon resturant, Mouza-Ichhapur in Blocks- Mahisadal & Nandakumar, District-Purba Medinipur, was discussed in the DSC meeting held on 05-02-2025. During meeting "it has been informed that one scheme at same reach accorded Administrative Approval under RIDF XXX, tender of which has been invited. To avoid overlapping of site, it has been resolved that the said e-NIT is to be cancelled at the earliest and one combined scheme on present ground reality is to be placed, after due recommendation of DLTC, to the Department for funding under CSDS or any other suitable source of fund".

Subsequently matter was discussed with Chief Engineer (SW) and Officials in this present meeting. It was decided that the scheme will be further reviewed in the next DSC meeting by superseding the decision of DSC meeting held on 05-02-2025. Accordingly, Chief Engineer (SW) is directed to resubmit (through OPMS) the scheme before the next DSC meeting with proper justification for taking up the scheme.

- Finally,4 no. schemes as per Annexure have been cleared by the DSC for inclusion under Core State Development Schemes during the current FY 2024-25.
- 8. It has been directed to submit the soft copy (PDF version) of all the schemes as per enclosed list duly technically sanctioned after incorporation of the minor changes as suggested in the DSC meeting.
