The Steering Committee would provide strategic supervision, policy guidance and steering support for the successful implementation of the project. The steering committee would also discuss the matters relating to various aspects of the project involving central agencies.

The Terms of Reference for the Committee will be as under:-

- i. To provide policy directions for the implementation of project
- ii. To exercise overall administrative, management and financial control of project
- iii. To approve the constitution of the Three Project Management Groups, HISMG (Tech), HISMG (IS), and HISMG (DD) to be set up for operational management of project on behalf of NSLC and periodically review their functioning.
- iv. To consider and approve any changes/deviations to the planned programs for project.
- v. To deliberate and ratify decisions not resolved at the level of the three HISMG
- vi. To oversee and review progress made in implementation of project (this would include Progress Reports and Technical Analysis Reports finalized by (HISMG) and make recommendations to SLSC for implementation in the State)
- vii. Resolve issues arising out of inter-agency coordination, if any.
- viii. Provide direction and support to State Level Steering Committees on policy matters related to project
 - ix. To constitute special purpose Working Group(s) / Task Force(s) to address specific aspects of the Project as a time-bound activity with a clearly defined deliverable by engaging specialists from the academia/ industry, as required. NLSC may also invite experts / appoint short-term consultant to address specific aspects of the project.
 - x. To appoint experts to carry out an assessment of the effectiveness of HIS to provide mid-course corrections, if any, and define policies that are needed to keep the system responsive to operator needs for technological improvements.

The National Level Steering Committee would meet as often as required but at least, two times a year.
