TERMS AND CONDITIONS

- The 01 (One) no. CANON LBP 151 DW and 01 (One) no CANON MF 3010 B Printers are to be installed in the office of the Superintending Engineer, Mahananda Barrage Circle, Tinbatti and 01 (One) no CANON MF 3010 B Printers are to be installed in the office of the Executive Engineer, Mahananda Canal Division, Tinbatti, Siliguri.
- Before submitting rates, it is necessary to inspect the above mentioned place of installation in orders to assertion all the facilities available there. Any short of claim what so ever, would not be entertained under any circumstances if difficulties are faced by quotationers during actual installation of work.
- 3. Rates quoted should be inclusive of all taxes, carriage and all incidental charges etc. complete.
- 4. Lowest quotation shall normally be determined considering the total value of the works as a whole and not considering the individual item wise value or works. However, the quotationers have to furnish the detailed break up of their rates as per different item.
- 5. Time allowed for supplying and installation of 01 (One) no. CANON LBP 151 DW and 02 (Two) no CANON MF 3010 B printer at the specified place and completion of works in all respects as per schedule of works is 10 (ten) days from the date of issue of the work order. The time for the completion of the work should strictly be adhered to.

- 8. Successful quotationer shall have to execute the formal agreement in W.B.F. no. 2908 at his own cost within 7(seven) days from the date of issue of the work order.
